Ek, die ondergetekende, beoog om deel te neem aan 'n geborgde Ontspannings-aktiwiteit ("Aktiwiteit") wat deur Tau Meule-Voere ("Tau") aangebied word, met die toestemming van die organiseerders van die 2023-NAMPO Landbou handelskou ("NAMPO") by die 2023-NAMPO Landbou handelskou-terrein, buite Bothaville, in die Vrystaatse provinsie van Suid-Afrika, op die toegewysde area.

I, the undersigned, intend for myself to participate in a sponsored Recreation activity ("Activity") held by Tau Meule-Voere ("Tau") with the consent from the organisers of the 2023-NAMPO Agricultural Trade Show ("NAMPO") at 2023-NAMPO Agricultural Trade Show terrain, outside Bothaville, in the Free State province of South Africa, on the dedicated area.

Ek erken en kom ooreen dat:

- die deelname aan die Aktiwiteit die volgende kan behels:
 - strawwe fisiese aktiwiteite, die risiko van liggaamlike beserings insluitend lewensverlies, of skade aan eiendom en ander gevare; en

- enige besluit en uitslag, soos deur die beoordelaars en/of beampes van die Aktiwiteit bepaal, finaal en bindend sal wees, sonder enige reg van appèl of hersiening; en
- dit my verantwoordelikheid is om die nodige navrae te doen rakende myself, my fisiese toestand of andersins, om veilig aan die Aktiwiteit deel te neem en dat, voor die ondertekening van hierdie Vrystelling, ek, op versoek, die geleenthed gebied is om my te vergewis oor die moontlike risiko's en gevare weens my deelname aan die Aktiwiteit; en
- ek myself ten volle vergewis het van die risiko van die moontlike benadeling en ten volle die aard en omvang van die moontlike skade aan myself as gevolg van my deelname aan die Aktiwiteit besef en aanvaar; en
- enige redelike vrae wat ek gehad het oor my vermoë om aan die Aktiwiteit deel te neem, tot my bevrediging beantwoord is, en ek genoeg inligting het of ontvang het om 'n nugter en vrywillige besluit vir myself te neem om aan die Aktiwiteit deel te neem; en
- daar sal nie mediese personeel by die plek van die Aktiwiteit beskikbaar sal wees nie; en
- Tau en/of NAMPO hiermee toestemming verleen word om, indien nodig, nood-mediese behandeling vir my te magtig, en dat sodanige optrede onderhewig is aan die bepalings van hierdie Vrystelling; en
- Tau, NAMPO of enige borg, te eniger tyd, sonder die verskaffing van redes, my deelname aan die Aktiwiteit mag weier of mag beeindig; en
- indien enige terme of bepaling van hierdie Vrystelling onafdwingbaar mag wees, sal alle oorblywende bepalings van hierdie Vrystelling steeds ten volle van krag en afdwingbaar wees.

I acknowledge and agree that:

- *the participating in the Activity may involve:*
 - *strenuous physical activity, risk of bodily injury including loss of life, property damage and other hazards; and*
 - *the possibility of being exposed to material that may result in allergic reactions or other harm.*
- *I am required to act in a responsible manner at all times during the Activity; and*
- *I will be held responsible for my behaviour and I must respect the property of Tau, NAMPO, any other sponsor and others; and*
- *any decision and result as determined by the adjudicators and/or officials of the Activity will be final and binding, without any right of appeal or review; and*
- *it is my responsibility to make the necessary inquiries regarding myself, my physical condition or otherwise, to safely participate in the Activity and that, prior to executing this Release, I have been provided, on request, the opportunity to inquire and discuss the possible risks and hazards to myself resulting from participating in the Activity; and*
- *I have fully acquainted myself with the risk of the possible prejudice and fully realise, accept and appreciate the nature and extent of the possible harm to myself resulting from myself participating in the Activity; and*

- any reasonable questions I had regarding my ability to participate in the Activity have been answered to my satisfaction, and I have or have received sufficient information to make a sound and voluntary decision for myself to participate in the Activity; and
- there will not be medical personnel available at the location of the Activity; and
- Tau and/or NAMPO is granted permission to authorise emergency medical treatment for me, if necessary, and that such action is subject to the terms of this Release; and
- Tau, NAMPO or any sponsor may, at any time, without given any reason, not accept or terminate my participation in the Activity; and
- should any provision or aspect of this Release be found to be unenforceable, all remaining provisions of this Release will remain in full force and effect.

Persoonlik en namens my familie, erfgename, begunstigdes en verteenwoordigers, aanvaar ek hiermee:

- the winners will be contacted by Tau's finance department to arrange for the transfer of the prize money via electronic bank transfer to an RSA bank account of the choice of the members of the winning teams;
- if I am in a working relationship with Tau or Nissan or any sponsor of the Activity, neither I nor any of my direct family will or may be considered for any prizes based on my or our participation.
